

Assistant Building Surveyor Grade 7

CONSULTANCY

This role is a two year training and development role expected to lead to full professional recognition as a Building Surveyor with either RICs or CIOB. You will provide support for Building Surveyors which covers all aspects of Building Surveying including project and planned maintenance delivery and will include supervision of appropriate works.

What you will deliver

It's about professional Building Surveying:

You will assist with all aspects of building surveying work including areas such as the coordination of building condition surveys, preparation of specifications and drawings, and planned and reactive maintenance.

It's about providing a Consultancy service in building conservation, maintenance and repair. You will respond to requests for information, advice and hands-on support to meet the needs of your profession and clients, including our Tenants. You will also analyse and disseminate external sources of information applicable to the Trust's building operation and undertake relevant research when necessary.

It's about promoting building standards:

You will actively participate in regional and national CPD events, following an agreed programme towards professional qualification.

It's about risk management & protection:

You will develop knowledge of managing risk and compliance. You will ensure that delegated cyclical compliance tasks are completed in a timely manner, and that any problems or difficulties achieving this are discussed at the earliest opportunity with your Consultancy Manager.

It's about good team work: You will actively participate in regional building and property meetings when requested, sharing knowledge and lessons learned from your experiences, including with other Assistants from all disciplines.

It's about maintenance management: You will assist with the management of maintenance and repairs within a property portfolio, organising reactive repairs and planned maintenance under direction of the Building Surveyor, Building Supervisor or Building Services Manager.

It's about planning & budgets: You will understand the process for the planning of cyclical works, improvements and projects, helping provide a professional building service to ensure high standards of building conservation, maintenance and repair.
